**1 – GENERAL CONDITIONS OF ACCESS TO L'ÎLE AUX DIX ROUES WEBSITE**

**WE INVITE YOU TO CAREFULLY READ THE FOLLOWING CONDITIONS THAT CONTRACTUALLY BIND ALL WEBSITE USERS TO L'ÎLE AUX DIX ROUES.**

**1.1 – INTELLECTUAL PROPERTY**

### **1.1.1 – COPYRIGHTS**
