The respect of privacy is a principle recognized by law, and we are fully aware of the importance it holds for you. By using our Website, you may collect information for yourself or for a third party. You may also send us information of a personal nature. L'ÎLE AUX DIX ROUES hopes that, when visiting this Website, you will feel completely secure in this regard. The present privacy policy explains:

- The type of information we collect,
- How we protect it, and
- Your choices on how said information will be used.

You may use L'ÎLE AUX DIX ROUES Website without sending us the type of information that would permit to identify you, such as name, address, phone number, e-mail, credit card number, etc. That type of information is consigned in the **Personal Information** category. Any personal information about you will be collected only if you send it to us voluntarily. Should you wish to withhold any or all the information requested on screen, and if confidentiality is important to you, you may do so.

1 DEFINITIONS

1.1 PERSONAL INFORMATION

In this present agreement, personal information is any information that would permit to identify a Website user.

1.2 COLLECTIVE INFORMATION

Any information collected by a user without permitting his (or her) identification is considered as collective information.

2 PERSONAL INFORMATION GATHERING

2.1 PURPOSE OF PERSONAL INFORMATION GATHERING

We will use any personal information you send us solely for the reasons they were sent. For example, we may use it to answer a request for additional information, or to permit someone to contact you in conformity with your specific request and authorization.

2.2 NO SALE WITHOUT PRIOR AUTHORIZATION

No personal information collected by L'ÎLE AUX DIX ROUES will be sold to "information brokers" or any other third party.

2.3 PERSONAL INFORMATION SUBJECT TO GATHERING

When submitting your own personal information, the following information may be gathered by L'ÎLE AUX DIX ROUES:

- Your name,
- Your postal or e-mail address,
- Your phone number,
- On occasion, we may ask you for additional information such as your age, date of birth, sex, level of education, profession, hobbies, and other interests, by way of surveys.

2.4 PERSONAL INFORMATION CONSERVATION TIME LIMIT

L'ÎLE AUX DIX ROUES declares that, unless otherwise stated, files containing personal information will not be kept any longer that the length of time required for the completion of their purpose.

2.5 ACCESS, CORRECTION AND WITHDRAWAL OF PERSONAL INFORMATION

You may gain access to your personal information at any time. To do so, contact us and ask to see what information about you has been gathered by our services.

You may ask that your personal information be corrected or withdrawn, without justification on your part.

2.6 USER CONSENT

L'ÎLE AUX DIX ROUES will not collect any personal information without prior authorization from the user.

3 PERSONAL INFORMATION SECURITY

3.1 TRANSMISSION

When deciding to transmit personal information, you should be aware on the risks inherent to information transmission through the Internet.

3.2 CONSERVATION

Notwithstanding the preceding, and within the normal technical capabilities of the Internet, L'ÎLE AUX DIX ROUES will ensure that your personal information remains confidential. L'ÎLE AUX DIX ROUES wishes to protect all personal information in its possession against all loss, improper use, or unauthorized modification.

4 COOKIES

As with most WebWebsites, we collect information on you and your use of the Website by means of "Cookies". These are small programs installed on the hard drives of our users that permit us to calculate the frequency of your visits to our Website, as well as which of our activities interested you. (Ex: Discussion Forums viWebsited, etc.).

This type of information, called "collective information", does not permit us to identify you nor to contact you. In addition, it helps us create dynamic Web pages offering content and advertising especially conceived for you. This information also permits us to establish statistics on the number of visitors to our Website and on the various subject matter consulted by users. Sponsors and advertisers may also install "cookies" when you click on their ads. You should be aware that we have no way of controlling the use of "cookies", nor the manner in which they exploit the information gathered in this way. Should you desire to block or delete these programs, most providers offer methods to do so.

5 VARIOUS CONDITIONS

5.1 MODIFICATIONS

L'ÎLE AUX DIX ROUES may at any time modify its Privacy Policy. In such case, L'ÎLE AUX DIX ROUES will use all proper diligence to notify users.

Moreover, your continued use of the Website after notification of modifications to the present agreement constitutes your agreement to the modified stipulations.

If you disagree with the Charter on the respect of privacy in whole, or with certain of its clauses, or if you should disagree with later possible modifications, you must immediately leave L'ÎLE AUX DIX ROUES Website, and most importantly, do not transmit any personal information about yourself.
